



### STATEMENT OF ELIGIBILITY FOR TRAINING

Vitruvian Defensive Solutions LLC ("Vitruvian") does not and shall not discriminate on the basis of race, color, religion (creed), gender, gender expression, age, national origin (ancestry), disability, marital status, sexual orientation, or military status, in any of its activities or operations. These activities include, but are not limited to, hiring and firing of staff, selection of volunteers and vendors, and provision of services. We are committed to providing a safe, inclusive, and welcoming environment for all members of our staff, volunteers, subcontractors, vendors, and clients.

We respect and value the safety and security of the general public, law enforcement, military, and all public safety and government officials. We provide training only to law-abiding citizens, as defined by applicable federal, state or local laws.

Vitruvian reserves the right to refuse or revoke service to anyone for safety considerations. Vitruvian reserves the right to use the following criteria for determining eligibility of individuals to receive services from Vitruvian: individuals who are not disqualified from possessing a firearm as defined by applicable federal, state or local law, are eligible to receive services from Vitruvian. Vitruvian further reserves the right to use the below list of Ineligible Persons categories when determining eligibility of an individual to attend any Vitruvian provided service. Vitruvian reserves the right to ask for documentation that would render an individual eligible for training to include but not limited to: a current Concealed Carry Weapons (CCW) Permit, background check result, fingerprint card, or other similar documentation subject to the approval of Vitruvian. Providing the documentation is voluntary, however, Vitruvian reserves the right to cancel the service and return any payment in accordance with Vitruvian's Return Policy if documentation is not provided.

#### INELIGIBLE PERSONS TO RECEIVE SERVICES FROM VITRUVIAN:

- Anyone convicted of a crime punishable by imprisonment for over one year; or, persons awaiting trial for a crime punishable by imprisonment for more than a year. Fugitives from justice.
- Unlawful users of depressant, narcotic, or stimulant drugs. This includes states where cannabis has been legalized.
- Those adjudicated as mental defectives or incompetents or those committed to any mental institution.
- Illegal Aliens.
- Citizens who have renounced their citizenship with the U.S.
- Anyone dishonorably discharged from the Armed Forces.
- Persons less than 21 (Federal is 18) for the possession of a pistol. (Waived by: \_\_\_\_\_)
- Persons under a court restraining order from harassing, stalking, or threatening an intimate partner or child of the intimate partner.
- Has been convicted of a misdemeanor crime of domestic violence.
- Is ineligible to own, posses, or receive a firearm under any restriction imposed by state or federal law.

**In signing this release, I acknowledge and represent that I HAVE READ THE FOREGOING Statement of Eligibility for Training, and that I UNDERSTAND IT AND HAVE SIGNED IT VOLUNTARILY** as my own free act and deed. I further attest I am fully eligible to receive services from Vitruvian. If it is determined that I am ineligible for training as defined in the FOREGOING Statement of Eligibility for Training after paying for a service, I fully accept any payment made for any service from Vitruvian is subject to the Return Policy of Vitruvian.
